WORK IN PROGRESS

Adversity and Resilience: The Effects of Hurricane Katrina on Vulnerable Populations (with Jean Rhodes, Christine Paxson, Cecilia Rouse, Elizabeth Fussell and Thomas Brock). A longitudinal study of 1,019 low-income parents from New Orleans who were interviewed about their health, socioeconomic status and political attitudes before and after Hurricane Katrina. We explore factors that promote resilience and heighten vulnerability within this group, through surveys of the whole group and in-depth qualitative interviews with a small subset. Funded by the National Institute of Child Health and Development (NICHD), National Science Foundation and the MacArthur Foundation.

Coming of Age in America. Co-editor (with Patrick Carr, Jennifer Holdaway and Maria Kefalas) of a volume analyzing the subjective experience of the transition to adulthood in New York, San Diego, Iowa, Michigan and Minnesota. Funded by the MacArthur Foundation.
